2. Closing time for Reporting of candidates for the Interview is at 10:00 AM on 05.03.2026, after which no additional candidates will be entertained for the interview.
3. The Recruitment is provisional and subject to variation, if deemed necessary. The Principal Investigator (PI) reserves the right to make any amendment, cancel and make changes to this advertisement as a whole or in part without assigning any reason or giving notice. The post is for the specified period and is based on the project, which may be modified at the discretion of the Principal Investigator as per requirement.
4. The above post would be filled purely on a temporary basis, co-terminus with the project & the candidate will have NO right to claim permanent Employment under AIIMS, Jodhpur or continuation of his/her services in any other project. The engagement will not confer any implicit rights upon the candidate to claim permanent absorption or impose any liability upon AIIMS, Jodhpur, upon termination of the contract.
5. The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the post applied for. They must meet the eligibility criteria as of the critical date mentioned (05.03.2026); failing to do so, their application will be rejected. Age / Education Qualification / Experience will be considered till 05.03.2026. Age relaxation of up to 5 years may be granted to deserving candidates with experience in a Government Research Organisation on ICMR projects, on a case-to-case basis, as per ICMR Rules.
6. Please note that all the necessary certificates & proof supporting your identity, essential qualifications and experience are required to be submitted with the application form. Otherwise, the application will be considered incomplete.
7. The Original documents have to be submitted at the time of the interview for verification, along with one self-attested photocopy of all documents and a printout of the application form received in your email after the due submission of the form.
8. All educational professional and technical qualifications should be from a recognised Board/University and be full-time. Qualifications may be relaxed for highly experienced, trained or reputed candidates only at the discretion of the Selection Committee.
