No.A.34012/2/2026-MPSC(PRE): Limited Competitive Examination for the under mentioned post is to be conducted by the Mizoram Public Service Commission. Application can be submitted through the Mizoram Public Service Commission's online portal <https://mpsconline.mizoram.gov.in>

Probable applicants who have not registered in the one-time-registration portal must register latest by 4:00 pm on the last date of submission of application.

An Applicant must verify that his/her application is actually submitted after payment is made, otherwise the claim of the Applicants regarding his/her Candidature will not be entertained.

- 1. Name of Department** : **DP&AR(CSW)**
- 2. Name of Post** : ***Junior Grade of Mizoram Civil Service***
- 3. Classification** : ***Group 'A' (Gazetted)***
- 4. No. of Posts** : ***3 (Three)***
- 5. Pay** : ***Level 10 in the Pay Matrix***
- 6. Relevant Rules** : ***Mizoram Civil Service Rules, 2022 and its amendments and MCS (Limited Competitive Examination) Regulations, 2023.***

7. Conditions of Eligibility and Qualification :

- i) From Officers in Group 'B' at Level – 07 of the pay matrix with 7(seven) years of regular service in the grade rendered after appointment thereto on a regular basis under the Department, Government of Mizoram. Provided that the period of service from Group 'B' at Level – 07 in the Pay matrix or above shall be reckoned for computing 7 (seven) years of regular service and not in a specific grade/post as on 1st August, 2026.
- ii) He must hold at least a three year degree of any of the Universities incorporated by an Act of the Parliament or State Legislature in India or other Educational Institutions established by an Act of Parliament or declared to be deemed Universities under section 3 of the University Grand Commission Act, 1956, or foreign Universities approved by the Central Government.
- iii) He must be a citizen of India.
- iv) He must not have exceeded the age of 54 years of age as on 1st August, 2026.
- v) Working Knowledge of Mizo Language of at list Middle School standard shall be compulsory.
- vi) A candidate must pay the fees prescribed by the Commission

Note 1: Candidates possessing professional and technical qualifications which are recognized by Government as equivalent to professional and technical degree would also be eligible for admission to the examination.

Note 2: Candidates should note that the date of birth as recorded in the HSLC or HSSL will be accepted by the Commission as valid proof of date of birth and no subsequent request for change shall be considered. No other document relating to age like horoscopes, affidavits, birth extracts from Municipal Corporation, Service records and the like will be accepted.

Note 3: All candidates will be required to submit an undertaking that they have informed in writing their Administrative Head/Cadre Controlling authority that they have applied for the Examination. Candidates should note that in case a communication is received from their employer by the Commission withholding permission to the candidates applying for appearing at the examination, their applications will be liable to be rejected/candidature will be liable to be cancelled.

8. Decision as to eligibility :

- i) The decision of the Commission as to be eligibility or otherwise of the candidates for examination shall be final and no candidate to whom an Admit Card has not been issued by the Commission shall be admitted at the examination.
- ii) The candidates applying for the examination should ensure that they fulfil all the eligibility conditions for admission to the examination. Their admission at the written examination for which they are admitted by the Commission will be purely provisional, subject to their satisfying the prescribed eligibility conditions. If on verification at any time before the Personal Interview, it is found that they do not fulfil any of the eligibility conditions, their candidature for the examination will be cancelled by the Commission.
- iii) No request for withdrawal of candidature received from a candidate after he has submitted his application will be entertained under any circumstances.

9. Documents to be submitted at the time of application :

- i) Documents to prove eligibility mentioned in 7(i) above.
- ii) Letter certified by the Head of Department/Cadre Controlling authority stating that they have no objection of him/her applying the post and that there is no vigilance case pending against him/her
- iii) Marksheet & Certificates to prove eligibility mentioned in 7(ii)

10. Disqualification :

- i) Canvassing by a candidate directly or indirectly will disqualify the candidate.
- ii) Particulars/Details to be mentioned in the application should be mentioned completely and correctly. Any application not specifying the required information of a concerned candidates shall be liable to be rejected.
- iii) Any candidate who, on verification at any stage of the recruitment process, does not fulfil any of the eligibility conditions will be disqualified.

11. Last Date of Application : 17.04.2026 till 4:00 PM
