

Mode of Selection: Selection will be done based on an **online interview** (through MS Teams/Skype/etc.). Date of the interview will be notified separately in **www.neeri.res.in website**.

1. The above positions are purely temporary and co-terminus with the aforementioned projects. The engagement in these projects will not confer any right, implicit or explicit, on the candidate for considering regularisation against any CSIR/CSIR - NEERI post(s). Moreover, under no circumstances would the tenure of project staff who have served CSIR-NEERI or any other laboratories/Institutes of CSIR under contract R&D projects be allowed to exceed six or seven, as the case may be, as per clause no. 1.6/1.7 of CSIR OM No. 5-1(342)/2017-PD Dated 02.09.2024 as amended from time to time.
2. Upper age limit shall be reckoned as on the last date of receipt of applications
3. Candidates are not required to pay any application fees.
4. Only those candidates who have acquired the essential qualification & result has been declared (should have at least a provisional certificate) are eligible to apply for a particular position.
5. Result awaited /Final semester appeared or PhD submitted candidates are not eligible to apply for the position where such a minimum essential qualification requirement is mandatory.

6. Final semester and result awaited candidates are not allowed to appear for the interview.
7. Experience, where required, will be counted from the date after acquiring the minimum educational qualification. Dissertation/ Thesis work done during the academic period will not be counted as experience.
8. Time spent in acquiring a higher qualification will not be counted as experience over the essential qualification.
9. Mere fulfilment of the minimum qualification does not confer any right in a candidate for being called for an interview. If a large number of applications are received, preference will be given to candidates based on the criteria adopted by the Screening Committee.
10. The shortlisted candidates will be invited for the online interview, and information will be uploaded on the website/ portal. **(Applicable only for online interview and not for walk-in interview)**
11. No upgradation of the project staff shall be done in the same or a new project. However, candidates have to apply fresh, and if shortlisted, have to appear for the interview.
12. CSIR-NEERI reserves the right to cancel or withdraw the offer of engagement in case of any discrepancy found in the candidature of any empanelled candidate at any stage.
13. The selected candidates are expected to join within the time frame mentioned in the offer letter from the date of receiving the offer letter of appointment, after completion of pre-appointment formalities like medical examination, character verification, etc.
14. Each selected candidate shall sign an undertaking for maintaining the confidentiality of project findings and/or any associated intellectual property information.
15. Engagement under the new project would be made only after the acceptance of the resignation from the previous project by the competent authority.
16. Engagement of project staff will depend on the project tenure/ requirement, which may be extended or curtailed depending on the duration of the Project/desired level of performance or conduct of the incumbent, as the case may be.
17. The engagement of project staff may be terminated at any time without assigning any reasons, by giving a one-month notice. In case the person desires to leave the assignment, he/she may also do so by giving one month's notice or payment of one-month remuneration in lieu of, which can be condoned/ curtailed at the discretion of the Competent Authority.
18. The project staff shall have to make their own arrangement for accommodation during their tenure in the project. However, HRA shall be admissible as per applicable rules.
19. The offer letter shall be issued to the candidate initially for a period for which funds are available.
20. A review committee will assess the performance of the project staff and recommend their extension, if required, subject to the availability of funds in the project.
21. CSIR guidelines for engagement of project personnel, as made applicable vide CSIR OM No. 5-1(342)/2017-PD dated 02.09.2024/ 18.10.2024 and amended from time to time, shall apply.
22. No TA will be paid to the candidates for appearing in the interview in case of offline interviews.
23. Other terms & conditions will be governed as per guidelines issued by the funding agency/ CSIR-NEERI for the engagement of the Project Staff as amended from time to time.
